## PUBLIC NOTICE FOR THE CREATION OF A SHORT LIST OF TECHNICAL-ENVIRONMENTAL EXPERTS OF CONSULTING AND SUPPORT TO SSI IN THE FRAMEWORK OF THE COLLABORATION WITHIN THE EUROPEAN ENVIRONMENTAL BUREAU (EEB)

### ARTICLE 1 OBJECT OF THE PROCEDURE

Given the Article 1 of the Statute, the SSI wants to have a short list of experts in disciplines related to caving that can support the work of the SSI and especially in supporting functions in the relationship with the European Environmental Bureau (EEB).

Interested person will present Curricula Vitae, the SSI will proceed with a specific assessment and inclusion in the short list.

The SSI reserves the right to modify, extend, suspend or revoke this call, should it detect the need and the opportunity.

### ARTICLE 2 BASIC REQUIREMENTS AND SELECTION CRITERIA

Candidates to participate in the procedure must possess proven experience in technical scientific disciplines: biology and hydrology or water management and policy related to conservation and speleology

Good knowledge of English.

#### ARTICLE 4 APPLICATION PROCEDURE

The application form ("Application submission form") may be presented by e-mail to the following address: [fse@socissi.it](mailto:fse@socissi.it) . and must include in the subject of the mail, under penalty of exclusion, the following wording "**application for the short list of SSI experts for EEB**".

The application must be completed in English and must be accompanied by a front / back photocopy of the candidate's identity document, a European format Curriculum Vitae<sup>1</sup> (PDF) written in English, under consequence of exclusion from the selection. At the bottom of the Curriculum Vitae, dated and signed, the declarations must be reported according to the D.P.R.n. 445/2000 and the authorizations to the processing of personal data ex. Legislative Decree 196/2003.

Applications must be submitted no later than 31/03/20 12.00 AM.

Applications received after the deadline indicated will not be accepted for this selection.

#### ARTICLE 5 EXAMINATION OF APPLICATIONS

The choice of the experts to be included in the short list will be taken care of by the Board of the SSI, which will examine the possession of the basic requirements declared by the participants.

Candidates in possession of the aforementioned requirements will be assessed on the basis of relevant professional experiences

Specifically, the Board will use the selection criteria listed for all. 3 of this Notice, for the attribution of reports, useful for drawing up the short final list.

## **ARTICLE 7 DATA PROCESSING**

The data communicated by the experts will be treated in accordance with the art. 13 of Legislative Decree no. 196/2003.

The data processing has the purpose of allowing the verification of the identity and the suitability of the competitors to participate in the procedure; they will be assigned separately for the investigation of the application sent and for the purposes to it

Connected. The data will be processed using both IT and paper tools.

At any time the interested party can apply his rights of rectification, updating and integration of data, as required by Legislative Decree n. 196/2003.
